**Voting will be January 11 at the annual Membership Meeting, 7:00 p.m. at the Community Center Clubhouse.** Each elected Director will serve a 2-year term beginning at the February 1, 2018 meeting.

The nominating committee has been reaching out since October to encourage members to serve on the board or to volunteer for committees. The Board continues to seek residents interested in leading or becoming involved in community activities. Please let a Board member know if you have any questions or might be interested in any of these community efforts:

**Disaster Preparedness and Recovery**, a new committee to collaborate with the SHFPD in furtherance of fire prevention and preparedness, including evacuation, and disaster recovery. Opportunities will include training, assisting with community safety events. We seek to develop a corps of residents much like block coordinators to, among other things, be aware of who may need help in an evacuation.

**Building and Grounds**, a new committee to help keep the community center and grounds running smoothly. We will lose the virtually full-time volunteer service of Steve Knox. We seek to fill his shoes with a combination of paid and volunteer staff to manage a variety of things including the cleaning and landscape maintenance contracts, club house rentals, and to identify/troubleshoot/and manage repairs as needed.

**Pool Committee**, a new effort to focus on increasing pool use by the community and satisfaction of pool members, as well as safety and cleanliness. We also need a Pool and Lifeguard Manager, another important role most recently filled by Steve Knox.

## News & Notes from Supervisor Katie Rice

### North Bay Fires – A Warning to all Marin

It's been just two months since the devastating North Bay fires first ignited, taking loved ones, destroying thousands of homes and hundreds of businesses, changing forever the lives of so many and entire communities as well.

Here in Marin, we stepped up as institutions and individuals to help our North Bay neighbors throughout the fire response and continuing into their recovery efforts. From our first responders who came from every agency in this County to fight the fire, to our disaster service workers and volunteers who supported evacuation centers, to the individual acts of generosity and support that have come in the form of contributions to relief funds, gift cards, food and supply donations, housing, I am incredibly proud of our County. My thanks to everyone who played a part in this effort.

The impact of the fires is being felt not only in the communities where they occurred, but in ripples and in some cases waves across the entire North Bay. They demonstrated all too harshly how easily wildland fire can sweep into more urbanized settings. As was the case in the early 1990's when first Loma Prieta hit followed by the Oakland Hills fires, the North Bay fires are a call to action that involves everyone – the public and private sectors, agencies, organizations, communities and individuals. Such events serve as a catalyst for us all to double-down on fire prevention, disaster and evacuation planning, and emergency preparedness generally.

As Supervisor representing the Ross Valley, an area of the County particularly vulnerable to wildfire, and in my role serving on FIRESafe Marin, a coalition of fire agencies, public land managers, utilities, organized neighborhoods and HOA's that was born out of the 1991 Oakland Hills fires, I am acutely aware of our ever-present wildfire risk. Hence the emphasis I have placed on efforts to reduce fire risk on both private and public property and to support enhanced communication, cooperation, and collaboration between the stakeholders – fire agencies, public land managers, HOA's and neighborhoods within and adjacent to the wildland urban interface.

The fire districts serving Ross Valley communities – from Larkspur and Kentfield to Ross Valley Fire, Sleepy Hollow Fire District and Marin County Fire—do an amazing job and do so in a coordinated/mutual aid fashion across district lines. In addition to fire, rescue, and medical response, these agencies (often supported by FIRESafe Marin) bring programs essential to preventing fire and supporting resident emergency preparedness in the form of defensible space inspections, fuel break/fire fuel reduction projects, sponsorship of CERT (Community Emergency Response Training) and Ready Marin (emergency preparedness) classes. The fire agencies also work closely with Marin County Open Space and Marin Municipal Water District, the agencies that manage the majority of public open space adjacent to our communities, to plan and implement fire fuel reduction work and maintenance of fire roads, in addition to mowing, maintaining and reducing accumulated fuel loads on thousands of acres of open space land every year.

The North Bay fires took a horrible toll, but they do serve as a catalyst for us to act, to maximize our efforts to prevent such an event from ever happening here. I will continue to support collaboration between agencies, communities and land managers, action and accountability on the part of utilities, aggressive fuel reduction programs on our public lands, and the involvement of individual residents, property owners and HOA's in prevention and readiness efforts. We all have a role to play.

Finally, sign up/make sure your current/all phones (cell phones and land lines) are registered with AlertMarin ([www.alertmarin.org](http://www.alertmarin.org)) – the countywide emergency alert system—the communication tool that will be used in the event of a fire or other emergency to communicate with residents.

### Winter Storm Preparation

It's that time of year again – rain, storms and potential flooding. Please take the time to read below and learn what you can do to be prepared!

**Sign Up for Emergency Alerts:** Register to receive emergency alerts sent from the County of Marin by phone, text, email, or even an app on a smart phone. Emergency officials use the Alert Marin System to deliver incident-specific information or potentially life-saving instructions to the precise geographic area(s) affected. Register at [www.AlertMarin.org](http://www.AlertMarin.org) and also sign up for Nixle texts at [www.nixle.com](http://www.nixle.com).

**Inspect/Clear all drainage areas:** Inspect drainage areas on your property (e.g. roof gutters, drain inlets, downspouts, pipes, drainage ditches) and clear your “watercourse.” Yard waste, broken branches, overgrown foliage, even leaves in drainage ditches, gutters can block storm drains and can cause localized flooding, affecting a down-street or down-stream neighbor, even if it doesn't affect you.

**Be Prepared for Flooding:** Use sand bags in areas known for flooding on your property – Sleepy Hollow Fire Protection District will have a sandbag station set up at the clubhouse during the rainy season for your use; Move vehicles to higher ground if in flood prone area; Move valuable possessions to the upper floors in your residence or business, if your property is subject to flooding; Secure outdoor furniture and other loose items to keep them from being blown away or carried by flood waters.

**Additional Preparations:** Make a family emergency plan, visit [www.ready.gov/make-a-plan](http://www.ready.gov/make-a-plan); Create a safety kit with drinking water, canned food, first aid supplies, blankets, radio flashlight and batteries; Check with elderly neighbors to see if they need any assistance with storm preparations.

**During the Storm:** Tune to local radio or television stations for emergency information and stay in place. If you must go out, avoid areas that are subject to flooding – do not drive through or walk through flooded areas – water as low as 6 inches deep can cause you to be swept away by strong currents.

## MMWD: WILDFIRE PROTECTION

The recent fires in Sonoma and Napa have focused all of us on the wildfire risks present in our communities. Wildfires are not unknown on our own Mt. Tamalpais. Between 1870 and 1915 the *Marin If* (or its predecessors) reported over fifteen significant wildfires on the mountain.

In July 1913 a wildfire, one of many over the years, devastated the Tamalpais watershed; swept by the winds it burnt for over five days. Residents were evacuated from Baltimore Canyon, and residents fled from Mill Valley, Corte Madera and Larkspur, and by July 10 of that year the fire had reached Muir Woods. Aid was sent from San Francisco and other nearby towns. Over 800 sol-

diers arrived from the Presidio and Angel Island. Engines, 15,000 feet of hose, and other equipment came from San Francisco. Today that same 1913 fire would cause untold damage and loss of life. Now there are 25,000 structures housing approximately 45,000 residents within two miles of water district lands along the Wildland Urban Interface, an area with a CalFire Fire Hazard rating that ranges from "High" to "Very High."

As a result of the 1913 fire, with the cooperative efforts of William Kent and the then newly created MMWD, the Tamalpais Fire Association was created. It was the first effort at organized wildfire fire prevention and protection; a joint cooperative among the water district and the then existing towns of Marin. Well know forester Frederic (Fritz Erskine Olmsted was hired and a crew was established for regular Tamalpais patrols and the construction of firebreaks. That early effort evolved into the water district's current staff of eleven ranges and mountain fire protection unit.

The district actively addresses fire protection: implementing measures that were recommended in the 1995 Vegetation Management Plan and by improving regional firefighting capabilities under the Fire Flow Improvement Program which was approved by the Marin voters in 1997 and continues today. Under the Fire Flow program the district has improved regional firefighting capabilities by replacing 82 miles of fire flow deficient piping, and replacing 42 redwood tanks with seismically designed steel tanks. The district works regularly with PG&E to facilitate and coordinate annual maintenance and inspection of power lines and adjacent vegetation. The district's annual budget reflects these efforts, and has been substantially increased with additional funds devoted to annual vegetation management which allows for additional resources to reduce wildfire hazards in strategic locations near local communities.

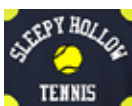
