HOME EVALUATIONS

The Sleepy Hollow Fire Protextion District

Uniformed Fire Inspectors will conduct Wildfire Defensible Space and Home Hardening Evaluations in Sleepy Hollow starting May 16, 2022. Inspections are conducted by the Marin Wildfire Prevention Authority (MWPA) in cooperation with the Ross Valley Fire Department and the Sleepy Hollow Fire Protection District (SHFPD).

A comprehensive online defensible space and home hardening report will be available approximately 24 hours after a property's inspection. This report provides steps to reduce each individual property's vulnerability and improve safety from wildfires. Some actions outlined in this report may be required by law - those must be corrected within 30 days.

Online reports are available to property owners, renters, and authorized representatives, and can be viewed online at http://dspace. marinwildfire.org. A six digit access code provided by the inspectors is necessary to view the report.

Residents can accompany inspectors during the property evaluation to learn about the importance of defensible space and homehardening. If nobody is home, that's OK! Inspectors will evaluate publicly visible areas of the property only, and leave instructions to retrieve the online report.

Evaluations are funded through Marin Tax Measure C (2020), Marin Wildfire Prevention Authority, Ross Valley Fire Department, and the Sleepy Hollow Fire Protection District.

Assistance Programs

There are several programs providing assistance to residents in order to address actions required in the home evaluation report.

- 1. MWPA Defensible Space Grant is awarded on a first-come, first-serve basis to all residents in amounts between \$100 (minimum) to \$1000 (maximum) per year, eligibility documentation is required.
- 2. MWPA Home Hardening Grant is awarded on a first-come, first-serve basis in amounts between \$100 (minimum) to \$500 (maximum) per year and this grant program requires a 50% match from the applicant. Eligibility documentation is required. Further information about both grants is available here: https://www.marinwildfire.org/resident-info/resident-grants
- **3. SHFPD Defensible Space Grant** is awarded on a first-come, first-serve basis and will provide up to \$599 for defensible space work identified in the home evaluation report. Further information is available here: https://www.shfpd.org/grants

4. SHFPD Direct Assistance Pilot **Program.** The program is awarded on a first-come, first-serve basis and will provide Sleepy Hollow residents with the opportunity to receive free hazardous vegetation removal and disposal services from a local, licensed contractor. Sleepy Hollow residents interested in participating in the program must submit an application by Friday, June 24th at 5:00 PM PST. Residents whose applications are approved will be contacted directly and all details will be confirmed. We expect work to be completed during August and September. Direct Assistance is a new pilot program. Residents will have the opportunity to provide feedback on the program at its conclusion. This feedback will be reviewed by the SHFPD and will help shape future investments in wildfire mitigation programs in our community.

5. CHIPPER DAYS: There are 5 chipper day events scheduled for Sleepy Hollow: Curbside pickup during weeks of: June 27th, July 25, August 29, and September 26th. An additional drop off event will be scheduled in the fall to coincide with creek cleanup.

MMWD: A Commitment for More Water

There is no doubt that Marin Water will continue its dedication to water conservation, including the promotion of its water-saving programs. However, there is also a growing commitment to increasing the water supply, and for finding new and reliable sources for that supply. The District's conservation programs and the search for additional water supply are not competing programs; instead, they represent the District's dual approach to reaching its goal – greater water supply security.

What are we doing for more water?


Marin Water has a detailed plan, which is now in the environmental review process, to build a pipeline along the Richmond-San Rafael Bridge that would carry water purchased from third parties to Marin to augment the District's water supply during times of community water shortages. Tentative agreements are underway with Cal-Trans, EBMUD, Contra Costa Water, City of Richmond, and others to work toward accomplishing that goal. With the pipeline infrastructure in place, the District would be able to potentially purchase water from the agriculture and irrigation districts of the Sacramento Valley, which each year, engage in an active water sales market.

In partnership with Las Gallinas Valley Sanitary District, Marin Water operates 24 miles of recycled water transmission and distribution pipeline in central and northern San Rafael. With over 300 recycled water service connections, the District provides over one million gallons of recycled water per day. The District is exploring potential additional opportunities to expand recycled water use for irrigation in areas where it could have the greatest impact on our water supply by replacing potable water use, including out to the Peacock Gap area, which would bring all of East San Rafael into the recycled water system.

This year, the District has increased the available Marin water supply by more than 5,000 acrefeet of additional water (equivalent to the volume of the Bon Tempe Reservoir). This achievement was made possible with the purchase and rehabilitation of the Kastania Pump Station, which enhanced the District's operational flexibility to accommodate delivering more Sonoma Water to Marin.



Through the District's current Strategic Water Supply Assessment effort, a closer look at greater integration of the Marin and Sonoma water systems is underway in addition to exploration of several other water supply alternatives. Notably, Jacobs Engineering Group, the consultant working with the District on its assessment, is currently performing similar services for Sonoma Water Agency. Marin Water's assessment project is also looking at desalination as an alternative, including a possible North Bay desalination project on the Petaluma River; increased winter water delivery from Sonoma Water; and increased local surface water storage. The assessment is also reviewing the proposed Richmond-San Rafael Bridge pipeline project and associated East Bay water purchases, as well as opportunities for regional recycled water, and potential cooperative approaches to accessing and storing the existing vast pools of Sonoma ground water. The District expects Marin Water's Strategic Water Supply Assessment to be a critical tool for measuring the costs and benefits of each supply option while accounting for various supply and demand scenarios to help guide the District through the decisions necessary to make our water supply more resilient. Several more Board of Directors working sessions and community workshops are planned for the Strategic Water Supply Assessment, and community members are encouraged to participate in these public meetings. Sleepy Hollow Homes Association Board Minutes of March 3, 2022

Sleepy Hollow Homes Association board convened 7 p.m. March 3, 2022 at 7 PM with Pete Mayer, President, presiding and directors Gina Singleton, Caroline Bruister, David Baker, Bryant Bedwell, Aya Andrews, Jan Blackford, Erik Ruud and Hayley Mullen in attendance. Supervisor Katie Rice joined as a guest. The previous month's minutes were approved, with Pete Mayer making the motion to approve and Gina Singleton seconding the motion.

Supervisor Rice spoke to the Board about the County Housing Element plan and its impact on Sleepy Hollow. By state law, the County supervisors are required to identify sites for 3800 low- and moderate-income housing units in unincorporated Marin. Two of these sites are located in Sleepy Hollow, at the San Domenico campus and atop the corral knoll just behind the Hidden Valley School, which sites are initially slated for up to 90 and 5 units respectively. Supervisor Rice noted that the county is only required to identify the sites and not to develop them; that determination is made on a commercial developer level. Mr. Mayer, Ms. Singleton, and Ms. Bruister updated the Board on their discussion with San Domenico School's CFO David Wise, who represented to the Board that the school's decision to volunteer part of their campus for development emanated from a desire to build employee housing and not to pursue any open to the public commercial development. The Board decided to send out Housing Element information to the Sleepy Hollow community prior to the next Marin County Board of Supervisors meeting on March 15 and to gauge community response before any further stance on the matter. Mr. Mayer shared with the Board a letter he sent to the Board of Supervisors prior to its last meeting, outlining concerns over large scale development on the San Domenico campus, which concerns included but were not limited to fire hazard and evacuation risk.

Ms. Blackford reported on Community Center construction progress, saying that locker room renovations were nearly complete but that there had been a delay in the outdoor shower build resulting from supply chain and other issues. The locker rooms are expected to be operable by the first week in April for swim team use. The Board then discussed bike corral layout and location, with concerns voiced over the safety of a location on Butterfield

Road and the feasibility of moving bicycle storage around the corner towards the Community Center courtyard, given the promise of that area for firesafe planting, or into the courtyard itself which some feel will itself be unsafe and result in bicycles cluttering the walkways. Mr. Baker and Mr. Mayer agreed to meet at the Community Center with designer Kai Broms to lay out the corral footprint and to explore alternatives on-site.

Mr. Mayer and Ms. Bruister spoke on their play area and play structure research. The choices at this stage, given budget constraints, are between either a fairly small scale natural installment or a larger, prefabricated play structure installation. The Board then discussed the competing interests at work in the decision, including participant age range, cost, and site capacity. Mr. Mayer, Ms. Bruister, Mr. Bedwell, Ms. Blackford, and Ms. Singleton agreed to meet at the Community Center to get a better feel for the physical layout and to discuss the alternatives in person.

Ms. Singleton updated the Board on the efforts of the Butterfield Safety Committee. The subgroup is making progress on designs for the Community Center crosswalk and is scheduling a community meeting to share the results of the Butterfield Corridor safety survey, which has so far garnered an enthusiastic response.

Ms. Mullens reported on membership goals for the 2022 season, saying that a 50% resident membership goal was realistic. This would result in 420family memberships, an approximately 8% increase from 2021. 205 members have already renewed or joined for 2022 in the first two months of the year. Auto renewals for SHHA and Senior SHHA will activate March 15. The Board discussed ways to make the auto-renewal program more intuitive and easier for members to elect..

Ms. Andrews reported that after a hiatus the Social Committee is getting back in to action. Among planned activities for the upcoming month include a new member hike and open house to assist with membership signup issues, a ladies' craft night, the Sleepy Hollow Presbyterian Church plant sale, and others. The Board discussed the weekly open hours concept, which has been slow to catch on amongst community volunteers. Mr. Mayer stated that he has been regularly been at the Community Center to act

as greeter but the attendance has been very poor, owing mostly to a lack of consistency and publicity. The Board resolved to adopt a more organized approach at staffing using the Sign Up Genius website and to put more effort into attracting volunteer greeters.

Ms. Blackford updated the Board on SHHA finances. Year-over-year revenue is flat, but cash is up substantially, showing the impact of increased memberships collected although revenue is deferred because the membership year extends 3 months into the next fiscal year. The Homes Association draft 990s are being reviewed with the expectation that they will be finalized in April. Mr. Bedwell reports that the SHHA will be able to use Bank of the West's Zelle cash transfers system once the Homes Association bank accounts are updated to reflect the new signing authority of Mssrs. Mayer and Bedwell which will drastically reduce the time it takes to make reimbursements to vendors.

Mr. Baker reported on pool maintenance. It had been previously determined, in consultation with the Sleepy Hollow Swim Team, to repair the underwater pool lights using the pool capital expenditures account and three of the four lights on the south wall were successfully repaired. The fourth, however, was unable to be repaired at first attempt and additional expenditures were required.

At 10:00 p.m., Mr. Mayer made a motion to adjourn, which motion was seconded by Ms. Singleton and unanimously approved by the Board.

Sleepy Hollow Homes Association Board Minutes of April 14, 2022

The Sleepy Hollow Homes Association Board convened 7pm April 14 at 7 pm with Pete Mayer, Spencer Adams, Gina Singleton, Caroline Bruister, David Baker, Aya Andrews, Jan Blackford, and Hayley Mullen in attendance. Kai Broms attended as a guest.

Mr. Baker and Mr. Broms led a discussion of the optimal placement and design for the bike corral outside the community center. Some concerns during swim team practice have arisen, including concern that the location along Butterfield could promote too much activity in a high car area, and that bikes parked out of sight from the courtyard may be more susceptible to theft. One bicycle, not locked, was taken in the first week of an ongoing trial. Board members spoke in favor of locating bike parking between the fire lane drive way and the south fence, and others pointed out that the corral's solid side is 11 feet from the sideline of the road, allowing the full bike lane plus extra footage, and the only open side is toward the footpath, and re-engineering drainage in the fire lane site would be expensive and that the corral has been on the drawings for a long time and should be given a trial. Directors agreed to continue the trial with conditions: a security camera system would be installed, signs recommending locks would be placed, and Mr. Broms would consider any other positioning of the corral that would put it further from Butterfield.

Mr. Mayer updated the Board on Verizon cell phone tower installation. Verizon has resubmitted their application to the county and is in the process of installing story poles in the proposed location.

Mr. Mayer led a discussion of the Housing Element proposal affecting the San Domenico campus and the area above the Hidden Valley School and noted that the feedback he received from the Sleepy Hollow community following the Board's communication in early March was generally positive and in favor of additional housing. The development numbers for the San Domenico site have been reduced by nearly half, and the Hidden Valley site by a third. The Board determined the best course of action is to keep community members aware of developments in the countywide Housing Element plan and, absent community feedback and encouragement, not to lodge any protest beyond its initial letter opposing the projects.

Ms. Singleton previewed the upcoming But-

terfield Safety Committee meeting scheduled for April 21. Proposed additions to the Butterfield Road corridor include a crosswalk at the Community Center and enhanced enforcement of bicycle lane parking.

Ms. Blackford updated the Board on Community Center construction. While the locker rooms are fully functional, completion of the outdoor showers is uncertain due to a construction defect in the footings for the surround wall but we do still anticipate a completion date no later than the end of May.

Ms. Bruister led a discussion of the playground design and construction. It was determined that Ms. Bruister, Mr. Mayer, and any other interested Board members visit Scientific Art Studio in Richmond and meet with their management to determine if there was a more naturalistic option available than the more standard play structure design. Fundraising options were discussed, with Mr. Adams in favor of a flash fundraising drive which has proven successful on other discrete design elements.

Ms. Andrews updated the Board on fundraising and social events. The Ukraine fundraiser was a tremendous success, with over \$31,000 raised for the refugee benefit effort, the Sleepy

Hollow Presbyterian Church's plant sale, this year joint with SHHA, raised around \$4,000 for county hunger programs. The Social Club will meet to discuss ideas for upcoming events but currently on schedule is another meeting of the Craft Cocktail Cabal and a Teen Band night, in addition to the Memorial Day weekend pool opening party and a June 11 social. [Subsequenyly changed to the May 29 Pool Members Opening Party and a June 4 community wide social to kick off summer.]

Ms. Mullen Reported membership numbers are so far robust, tracking ahead of last year's pace. Special consideration was given to enhancing efforts to drive Friends of Sleepy Hollow Membership and it was determined to review the website membership page language to make sure it is welcoming to all, residents and non-residents alike. New resident events will take place in May and June, including a Johnny's Doughnuts breakfast meetup and hike others.

Ms. Blackford made a motion to add Community Center superintendent Eric McAusland as an authorized signatory to the SHHA "clubhouse" checking account, so that he is able to spend against the maintenance/repairs budget to carry out pool and community center projects without having to seek reimbursement. Mr. Adams seconded the motion, which carried unanimously.

The meeting adjourned at 8:45 p.m until June 2, 2022 at 7:00 p.m.




